

VILLAGE OF BOYLE

BYLAW 08-24

BEING A BYLAW OF THE VILLAGE OF BOYLE, IN THE PROVINCE OF ALBERTA, TO ESTABLISH RATES, FEES, AND CHARGES FOR SERVICES PROVIDED BY THE MUNICIPALITY.

WHEREAS the *Municipal Government Act* ("Act"), RSA 2000, c. M-26, as amended from time to time, authorizes Boyle Village Council to establish and adopt bylaws for municipal purposes respecting services provided by or on behalf of a municipality and the establishment of fees for license permits and approvals.

AND WHEREAS, the *Safety Codes Act*, R.S.A. 2000, Chapter S-1, as amended or repealed and replaced from time, authorizes an accredited municipality to make bylaws respecting fees for anything issued or any material or service provided pursuant to the Safety Codes Act;

NOW THEREFORE, pursuant to the provisions of the Municipal Government Act, the Council of the Village of Boyle, duly assembled, enacts as follows:

1. TITLE

- 1.1 This Bylaw may be referred to as the "Fees and Charges Bylaw" of the Village of Boyle.

2. DEFINITIONS

- 2.1 The following terms shall have the following meanings in this Bylaw:
- (a) "Bylaw" means this Fees and Charges Bylaw established by the municipality.
 - (b) "Council" means the municipal Council for the Village of Boyle.
 - (c) "GST" means the Canadian Goods and Services Tax.
 - (d) "Village" means the municipal corporation of the Village of Boyle.

3. APPLICATIONS

- 3.1 The fees and charges shall be as detailed in the following Schedules, which is attached to and forms part of this bylaw:
- (a) Schedule "A" – Administration
 - (b) Schedule "B" – Public Works
 - (c) Schedule "C" – Planning & Development
 - (d) Schedule "D" – Safety Codes Permits
 - (e) Schedule "E" – Utilities
 - (f) Schedule "F" – Other Services
 - (g) Schedule "G" – Recreation
 - (h) Schedule "H" – Arena

(i) Schedule "I" – Community Centre

3.2 In the event of a conflict between a Fee set out in this Bylaw and the amount of a fee, rate or charge in an Applicable Bylaw, the Fee set out in this Bylaw prevails.

3.3 Despite Section 3.2, in the event a fee, rate or charge referenced in another Municipal Bylaw has not been included in this Bylaw, the Municipality may continue to levy a fee, rate or charge that is prescribed in that bylaw.

3.4 In the event that the Government of Alberta establishes a fee, rate or charge for a matter otherwise governed by this bylaw, the provincial fee, rate or charge shall prevail.

3.5 Method of payment for Fees, Rates and Charges to be at the discretion of the Village.

4. SEVERABILITY

4.1 If any clause in this bylaw, including any part of any schedule, is found to be invalid, it shall be severed from the remainder of the bylaw and shall not invalidate the whole bylaw.

5. BYLAW REVIEW

5.1 This Bylaw shall be reviewed annually by Council no later than November 30th of each year.

6. REPEAL

6.1 That Bylaw 08-23 is hereby repealed.

7. EFFECTIVE DATE

7.1 This Bylaw shall take full effect upon the date of third and final reading.

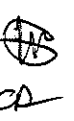
